## 2022/2023 Keio CEMS MIM Programme Application Guidelines For Keio Outgoing Students (1st Application period)

This document provides important information for students in the Graduate School of Economics, the Graduate School of Business and Commerce, and the Graduate School of Media Design who wish to apply for the CEMS Master's in International Management (MIM) Programme. If you wish to apply for the CEMS MIM Programme but are not enrolled in any of these graduate schools, please follow the Master's program application guidelines provided by the respective graduate schools. You will be eligible to apply for the CEMS MIM Programme after you are enrolled in or have been admitted for entry into one of the three graduate schools.



#### I. APPLICATION PROCESS

The Keio CEMS MIM Programme is a double-degree programme offered by the Graduate School of Economics, the Graduate School of Business and Commerce, and the Graduate School of Media Design. Since it is a double-degree programme, you will not be able to earn the CEMS MIM degree alone without receiving a Master's degree from one of these graduate schools. Please note, as shown in the flow chart below, the semesters (Term 1/Term 2) and the universities where you will study abroad will not be decided at the time you are selected as a Keio CEMS student. From the perspective of developing globally active talent, CEMS seeks students who enthusiastically exert their utmost effort wherever they are in the world.



- \*1 You will have an opportunity to indicate your preferences in terms of study-abroad terms and universities when filling out the CEMS Common Application Form (online form). Based on your preferences, your study-abroad terms and destinations will be determined by the CEMS Steering Committee after the Final Interview. However, there is no guarantee that you will be nominated to study abroad in your preferred terms and at your preferred universities. You are not allowed to change your school preference after the application deadline.
- \*2 Students are required to pay a Student Registration and Handling Fee of €100 (As of June 2021) to CEMS headquarters. As a rule, students of the CEMS MIM Programme are exempt from tuition fees at the schools they attend abroad (some institutions charge students additional fees for certain programs, such as Block Seminars). CEMS students shall bear the cost of the airfare and living expenses (e.g., rent, food, transportation, and other expenses).
- \*3 Term dates vary depending on each CEMS school's schedule.
- \*4 CEMS Graduation takes place once a year in November/December at one of the CEMS schools.

#### **Application Qualifications**

Applicants must meet all the conditions listed below:

1. Eligibility	By the time you submit your application, you must be currently enrolled in
	or planning to be enrolled in the Master's programme at either:
	(1) The Keio University Graduate School of Economics
	(2) The Keio University Graduate School of Business and Commerce
	(3) The Keio University Graduate School of Media Design
	Note: If you are currently receiving, planning to apply for, or to receive any
	scholarship(s), you must consult with both the scholarship office and the
	graduate school you belong to before preparing your application since the
	recipients of scholarships may be restricted to study only within Japan
	which will prevent you from satisfying the CEMS study-abroad
	requirements.
2. Language Proficiency	All applicants must be competent in English at the time of application.
	Applicants should be aware of the CEMS language graduation
	requirements upon applying for the CEMS MIM Programme. Please refer
	to the Language Graduation Requirement section to learn more.
	Provide proof of proficiency in English (if not your mother tongue) through
	any of the following (minimum level given):
	- TOEFL iBT100; IELTS(Academic)/IELTS Indicator 7.0; CPE C; CAE B;
	BEC Higher B
	- Have passed one of the CEMS-accredited locally accepted English
	exams
	- A Bachelor's diploma entirely taught in English from an English speaking
	country, or in a CEMS or an EQUIS/AACSB accredited institution
	-A Bachelor's diploma from the PEARL Programme offered by the Faculty
	of Economics, Keio University
	- A-level GCSE issued in Singapore

	X You are required to submit the proof of proficiency in English along with all the other application documents. If you are unable to meet the CEMS requirements at the time of the application but still have a strong desire to participate in the programme, please consult with the Keio CEMS Office or the Office of Student Services of your graduate school in advance as the application could be conditionally accepted
	in some cases.
3. Academic Preparation	You must meet one of the following two conditions to demonstrate your academic preparedness for the CEMS MIM Programme at the time of your application:  (1) You must have obtained a Bachelor's degree in either management, economics, or a related field; or  (2) You have successfully passed minimum 60 ECTS of full-time business education (eventually to be presented at the programme start).  Note: If you are a Master's student in the Graduate School of Media Design and have not received a Bachelor's in Management, Economics, or related fields, or successfully passed minimum 60 ECTS of full-time business education (eventually to be presented at the programme start), in addition to the application documents, you are required to submit a statement that describes your background (educational background and work experience) to demonstrate that you satisfy the conditions above.

## **How to Apply**

After you have thoroughly read the "Application Qualifications" section above, you must:

- (1) complete your online registration at the CEMS website below.

- (2) submit all the application materials, as given in the "Application Materials" section to the graduate school which you belong to. The documents must be in order listed below. Do not use staples.

#### **Application and Selection Schedule**

Keio offers two application periods, one in the fall and one in the spring. You may apply in either period, however, applicants for the second application period should note that: (1) students who are admitted to the CEMS MIM Programme during the first application period are usually allocated to the CEMS universities/terms before the second application period begins, which results in applicants for the second application period having fewer choices in terms of term abroad destinations; and (2) some CEMS schools set their deadline for incoming CEMS students' registration before the end of Keio's second application period.

The final decision on entry into the CEMS MIM Programme is made by the CEMS Steering Committee. The CEMS Steering Committee determines selectees' study-abroad locations and terms after the selection results are announced.

8. Additional Documents (KMD students only)	A statement that describes your background (educational background and working experience) to satisfy the conditions described in "Academic Preparation" on Page 3. (A4-size paper, one page)

1. CEM MIM year	CEMS MIM Year consists of Term 1 (corresponds to Keio's Fall Semester),
	Term 2 (corresponds to Keio's Spring Semester), and Term 3, which is an
	International Internship for a minimum of 8 consecutive weeks (see 7. below).
	Students who participate in the CEMS MIM Programme must spend two out of
	the three terms outside the country where the student's home institution is
	located. Students are not able to spend both Term1 and Term 2 at the same
	CEMS member School. A student must always successfully pass a minimum
	of <u>24 ECTS</u> per term. No more than 15 ECTS in elective and Skill Seminar
	credits may be taken outside the MIM year.
2. Block Seminar	The Block Seminar is a one-week course that takes place at the beginning of
	Term 1. Block Seminars bring together professors and students from various
	CEMS institutions. Subjects derive from different cultural and academic
	perspectives; many topics are not a part of the universities' standard curricula.
3. CEMS Courses	Students must pass CEMS Courses accounting for 45 ECTS credits in the MIM
	Programme. During Term 1, students have to successfully complete a CEMS
	Course in the field of "Global Strategy". During Term 2, similarly, students have
	to successfully complete a CEMS Course in the field of "Global Leadership",
	and "Hard Skills courses" in Term 1 & 2. These specified courses are offered
	exclusively to CEMS students.
4. Skill Seminars	Students must attend four Skill Seminar days in total (1 day = 8 hours = 0.5
	ECTS).

	Skill Seminars are training seminars in practical skills. They are essential to kick-starting an effective professional career and fundamental to adjusting easily to an international management environment. Topics may include: Business communication, Strategy skills, Personal development, Consulting skills, Marketing tools, Group work abilities, Negotiation techniques, Career development, and Presentation skills.
5. Global Citizenship	The Global Citizenship Seminar is a two-day course and takes place at the
Seminar	beginning of Term 2. The Global Citizenship Seminar brings together
	representatives from Corporate and/or Social Partners, professors and
	students, for an experiential learning opportunity.
6. Business Project	Students must carry out a Business Project accounting for 15 ECTS during
	Term 2. Business Projects reinforce the partnership between universities and
	companies in jointly shaping the students' learning processes in international
	management. They are consultancy-like projects designed as a real-life
	learning experience for students: international student teams solve a real
	business problem as a one-term, part-time activity.
7. International	Internships provide students with the real-life professional learning experience
Internship	of integrating in an organisation's culture and processes. The main objective
(Term 3)	is to turn academic experience and theoretical knowledge into a professional,
