2020/2021 Keio CEMS MIM Programme Application Guidelines For Keio Outgoing Students

This document provides important information for students in the Graduate School of Economics, the Graduate School of Business and Commerce, and the Graduate School of Media Design who wish to apply for the CEMS Master's in International Management (MIM) Programme. If you wish to apply for the CEMS MIM Programme but are not enrolled in any of these graduate schools, please follow the Master's program application guidelines provided by the respective graduate schools. You will be eligible to apply for the CEMS MIM Programme after you are enrolled in or have been admitted for entry into one of the three graduate schools.



I. APPLICATION PROCESS

The Keio CEMS MIM Programme is a double-degree programme offered by the Graduate School of Economics, the Graduate School of Business and Commerce, and the Graduate School of Media Design. Since it is a double-degree programme, you will not be able to earn the CEMS MIM degree alone without receiving a Master's degree from one of these graduate schools. Please note, as shown in the flow chart below, the semesters (Term 1/Term 2) and the universities where you will study abroad will not be decided at the time you are selected as a Keio CEMS student. From the perspective of developing globally active talent, CEMS seeks students who enthusiastically exert their utmost effort wherever they are in the world.



*1 You will have an opportunity to indicate your preferences in terms of study-abroad terms and universities when filling out the CEMS Common Application Form (online form). Based on your preferences, your study-abroad terms and destinations will be determined by Keio when you are selected as a CEMS student. However, there is no guarantee that you will be nominated to study abroad in your preferred terms and at your preferred universities. You are not allowed to change your school preference after the application deadline.

*2 Students are required to pay a Student Registration and Handling Fee of €100 (As of May 2019) to CEMS headquarters. As a rule, students of the CEMS MIM Programme are exempt from tuition fees at the schools they attend abroad (some institutions charge students additional fees for certain programs, such as Block Seminars). CEMS students shall bear the cost of the airfare and living expenses (e.g., rent, food, transportation, and other expenses).

*3 Term dates vary depending on each CEMS school's schedule.

*4 CEMS Graduation takes place once a year in November/December at one of the CEMS schools.

Application Qualifications

Applicants must meet all the conditions listed below:

1. Eligibility	<p>By the time you submit your application, you must be currently enrolled in or planning to enroll in the Master's programme at either:</p> <ul style="list-style-type: none">(1) The Keio University Graduate School of Economics(2) The Keio University Graduate School of Business and Commerce(3) The Keio University Graduate School of Media Design <p>Note: If you are currently receiving, planning to apply for, or to receive any scholarship(s), you must consult with both the scholarship office and the graduate school you belong to before preparing your application since the recipients of scholarships may be restricted to study only within Japan which will prevent them from satisfying the CEMS study-abroad requirements.</p>
2. Language Proficiency	<p>All applicants must be competent in English at the time of application. Applicants should be aware of the CEMS language graduation requirements upon applying for the CEMS MIM programme. Please refer to the Language Graduation Requirement section on page 8-10 to learn more.</p> <p><u>Language 1: English</u></p> <p>Excellent oral and written skills in English. Provide proof of proficiency in English (if not your mother tongue) through any of the following (minimum level given):</p> <ul style="list-style-type: none">- IELTS 7.0, TOEFL iBT100, CAE B, BEC Higher B or CPE C- Proof of having passed one of the CEMS-accredited local English exams- A Bachelor's diploma entirely taught in English from an English speaking country, or in a CEMS or an EQUIS/AACSB accredited institution- A-level GCSE issued in Singapore

	<p>※ You are required to submit the proof of proficiency in English along with all the other application documents. If you are unable to meet the CEMS requirements at the time of the application but still have a strong desire to participate in the programme, please consult with the Keio CEMS Office or the Office of Student Services of your graduate school in advance as the application could be conditionally accepted in some cases.</p> <p>If your mother tongue is neither English nor a CEMS language, you are required to submit the following to prove your language proficiency:</p> <ol style="list-style-type: none"> 1. English proficiency as indicated previously; AND 2. A) The results from a CEMS approved commercial exam, stating that the level of your language competency in one of the CEMS languages (apart from English) is at least at the B2 level for oral ability, and the B1 level for written ability. <p>OR</p> <p>B) If you select Japanese as a CEMS language and you do not have any proof of CEMS approved commercial exam results for Japanese, you need to take the CEMS MBC Language Test at Keio University and receive at least B2 on the oral exam and B1 on the written exam.</p>
3. Academic Preparation	<p>You must meet one of the following two conditions to demonstrate your academic preparedness for the CEMS programme at the time of your application:</p> <ol style="list-style-type: none"> (1) You must have obtained a Bachelor's degree in either management, economics, or a related field; or (2) You have successfully completed the equivalent of one year of full-time education at the Master's level in any of these areas. <p>Note: If you are a Master's student in the Graduate School of Media Design and have not received a Bachelor's in Management, Economics, or related fields, or you have not received the equivalent to one year of full-time graduate level education at the Master's level in any of these areas, in addition to the application documents, you are required to submit a statement that describes your background (educational background and work experience) to demonstrate that you satisfy the conditions above.</p>

How to Apply

After you have thoroughly read the “Application Qualifications” section above, you must: (1) complete your online registration at the CEMS website, and (2) submit all the application materials, as given in the “Application Materials” section. Please access the CEMS web registration website to begin your online registration by selecting the registration link under “Japan/Keio University” during the web registration period.

Application and Selection Schedule

Keio offers two application periods, one in the fall and one in the spring. You may apply in either period, however, applicants for the second application period should note that: (1) students who are admitted to the CEMS programme during the first application period are usually allocated to the CEMS universities/terms before the second application period begins, which results in applicants for the second application period having fewer choices in terms of term abroad destinations; and (2) some CEMS schools set their deadline for incoming CEMS students’ registration before the end of Keio’s second application period.

*5 Only Applicants who have successfully passed the internal screening in each graduate school can proceed to the CEMS interview. The final decision on entry into the CEMS programme is made by the CEMS Steering Committee. The CEMS Steering Committee determines selectees’ study-abroad locations and terms after the selection results are announced.

Location for Submitting Applications (No application materials are accepted by mail)

During the application period stated in the “Application and Selection Schedule” section on Page 5, you must arrange each set of the application documents in order listed below and submit them to the graduate school which you belong to. Do not use staples.

- Students enrolled or planning to enroll in the Graduate School of Economics or the Graduate School of Business and Commerce should submit their applications in person to the Graduate School at the Office of Student Services on Mita Campus.
- Students enrolled or planning to enroll in the Graduate School of Media Design should submit their applications in person to the KMD Office at Hiyoshi Campus.

Application Materials

1. CV	This must be written in English and have a photo attached. There is no specific format, but you should use A4-size paper.
2. Statement of Purpose	This must be written in English. There is no specific format, but you should use A4-size paper and keep the length of the statement to within 2 pages.
3. Mother Tongue Declaration Form	Retrieve the CEMS Mother Tongue Declaration Sheet from the link below, complete, and submit it along with your other application materials. The Mother Tongue Declaration Sheet is available at: http://www.ic.keio.ac.jp/en/study/cems/keio/cems_mother_tongue_df.pdf Note: Once you submit this form, you are unable to change the language you declared as your mother tongue.
4. Language Proficiency Certificate (<u>Original Copy required</u>)	Submit a photocopy of the relevant English language proficiency test certificate listed in “2. Language Proficiency” in the “Application Qualifications” section above. When you submit your application, you must bring the original certificate so that the photocopy can be verified. You should also note the following rules: <u>※ You must submit proof of your current English proficiency to the Keio CEMS Office at the time of your application. However, if you are unable to meet the CEMS English requirement at the time you submit your application but still have a strong desire to participate in the programme, make sure to consult with the Keio CEMS Office in advance as the application could be accepted in some cases on the condition that you submit proof that you meet the CEMS English requirement by the day before the Final Interview at the latest.</u> (1) For TOEFL scores, you should submit a copy of your “Examinee’s Score Record”; for IELTS scores, you should submit a copy of your “Test Report Form (Academic Module).”

	<p>(2) If you have not received a hard copy of your test certificate, but the score is available in some form online, you may submit a printout of the relevant webpage.</p> <p>(3) TOEFL ITP (Institutional Testing Program) scores are not acceptable.</p> <p>(4) A certificate for a language test that you took more than two years before the final date for submitting applications is not acceptable.</p> <p>(5) Students who wish to study at ESADE (Spain) in Term 2 (Feb.-July) must submit a Spanish test certificate (through any credible certification).</p> <p>If your mother tongue is neither English nor a CEMS language, you are required to submit the following proof:</p> <p>(1) Results from a CEMS approved commercial exam, stating that the level of your language competency in one of the CEMS languages (apart from English) is at least B2 oral/B1 written.</p> <p>OR</p> <p>(2) If your CEMS language is Japanese, and you do not have any proof of CEMS approved commercial exam results, you need to take the CEMS MBC Language Test at Keio University and receive at least B2 oral/B1 written.</p>

II. CEMS MIM GRADUATION REQUIREMENTS

Besides completing the Master's program in one of the three Keio graduate schools, you need to fulfil three key components of the CEMS programme; Term 1 (corresponds to Keio's Fall Semester), Term 2 (corresponds to Keio's Spring Semester), and Term 3, which is an International Internship for a minimum of 8 consecutive weeks. Students who participate in the CEMS MIM Programme must spend two out of the three terms outside the country where the student's home institution is located. Students are not able to spend both Term 1 and Term 2 at the same CEMS member school.

ONGOING LANGUAGE TRAINING AND TESTING					

1. CEM MIM year	Students who participate in the CEMS MIM Programme must spend two out of the three terms outside the country where the student's home institution is located. Students are not able to spend both Term1 and Term 2 at the same CEMS member School. A student must always successfully pass a minimum of 24 ECTS per term. No more than 15 ECTS in elective and Skill Seminar credits may be taken outside the MIM year.
2. Block Seminar	A Block Seminar is a one-week course which takes place at the beginning of Term 1. Students are automatically assigned to the Block Seminar of their Term 1 school. However, as long as places are available and with the permission of the school hosting the student during Term 1, students may apply for a block seminar different from the one held at their Term 1 school.
3. CEMS Courses	A minimum of 45 ECTS credits must be completed. Out of the 45 ECTS, the Global Strategy Course (Term 1), and the Global Management Practice Course (Term 2) are mandatory.

4. Skill Seminars	Students must attend four Skill Seminar Days in total, of which two are the mandatory “Business Communication Skill Seminar” in Term 1.												
5. Responsible Global Leadership Seminar	The Responsible Global Leadership Seminar (RGL) is a two-day course, which takes place at the beginning of Term 2.												
6. Business Project	Students must carry out a Business Project accounting for 15 ECTS during Term 2.												
7. International Internship	Internship must cover a period of at least 8 consecutive weeks full-time in the same company (the first 8 weeks of a full-time employment position are also accepted). It can take place at any time (even prior to CEMS selection), except during the two academic MIM terms.												
8. Language Graduation Requirement	<p>All CEMS MIM students graduate with competence in three languages, one of which must be English (at an advanced level) and another which must be a CEMS language.
